

MINUTES
Bloomfield Borough Council
Reorganization Meeting
January 2, 2018

Bloomfield Borough Council met this evening in their reorganizational session in the Bloomfield Borough Council Chambers with the following Council members present: President Malinda C. Anderson, Vice President John J. Patterson V., Charles N. Summers, Michael P. Pray and Karl L. Cless. Kevin C. Weller and Pierce L. Clouser, Jr. excused absences.

Also present: Secretary Danielle Shope, Mayor Arlis Krammes, Assistant Borough Secretary Kathleen Miller, Borough Employee Damon Hartman, Water Authority and Zoning Officer Ed Albright, Perry County Times reporter Jim Ryan, and Gay and Charles Summers.

Mayor Arlis Krammes called the meeting to order at 6:30 p.m.

Oaths of Office – Mayor Arlis Krammes swore in Bloomfield Borough Council members John J. Patterson V., Michael P. Pray and Charles N. Summers.

Nominations for President – Mayor Krammes asked for nominations for the position of Bloomfield Borough Council President. Councilman Cless made a motion, seconded by Councilman Patterson, to nominate Malinda C. Anderson as Bloomfield Borough Council President. Motion carried.

Nominations for Vice President – Mayor Krammes asked for nominations for the position of Bloomfield Borough Council Vice-President. Councilman Pray made a motion, seconded by Councilman Summers, to nominate John P. Patterson V. as Bloomfield Borough Council Vice-President. Motion carried.

Mayor Arlis Krammes then turned the gavel over to President Anderson.

Nominations for President Pro Tem – President Anderson asked for nominations for President Pro Tem. Vice President Patterson made a motion, seconded by Councilman Summers, to nominate Michael P. Pray. Motion carried.

Appointments/Reappointments to Boards and Committees -

5 Year Terms

President Anderson stated there is a 5 year reappointment to the Bloomfield Municipal Authority of Mr. Robert J. Wood to serve from 1/1/2018-12/31/2022. Councilman Cless made a motion, seconded by Councilman Pray, to approve Mr. Wood. Motion carried.

President Anderson stated there is a 5 year reappointment to the Bloomfield Borough Water Authority of Mr. Edward T. Albright, Jr to serve from 1/1/2018-12/31/2022. Councilman Summers made a motion, seconded by Councilman Pray, to approve Mr. Albright. Motion carried.

President Anderson stated there is a 5 year reappointment to the Bloomfield Borough Planning Commission of Melanie E Rowlands to serve from 1/1/2018-12/31/2022. Councilman Cless made a motion, seconded by Vice-President Patterson, to approve Ms. Rowlands. Motion carried.

President Anderson stated there is a 5 year reappointment to the Bloomfield Borough Shade Tree Commission of Mayor Arlis J. Krammes to serve from 1/1/2018-12/31/2022. Councilman Pray made a motion, seconded by Vice-President Patterson, to approve Mayor Krammes. Motion carried.

3 Year Terms

President Anderson stated there is a 3 year reappointments of Mr. Laurence W Brodisch to the Bloomfield Borough Zoning Board to serve from 1/1/2018-12/31/2020. Councilman Pray made a motion, seconded by Councilman Summers, to approve Mr. Brodisch. Motion carried.

Solicitor - President Anderson Council must acknowledge the reappointment of P. Richard Wagner as Borough Solicitor to serve for a period of a year from 1/1/2018-12/31/2018. Vice President Patterson made a motion, seconded by Councilman Summers, to approve Mr. Wagner. Motion carried.

Engineering Firm - President Anderson stated they had to confirm the Engineering Firm of Herbert, Rowland, and Grubic, Inc. for a period of one year from 1/1/2018-12/31/2018. Councilman Pray made a motion, seconded by Councilman Cless, to approve the firm of Herbert, Rowland, and Grubic, Inc. Motion carried.

President Anderson stated this ended the reorganization meeting for Bloomfield Borough Council. Vice President Patterson made a motion, seconded by Councilman Cless, to adjourn the meeting. Motion carried
