Bloomfield Borough Council
Reorganization Meeting
January 6, 2020

Bloomfield Borough Council met this evening for its reorganization meeting in the Bloomfield Borough Council Chambers with the following council members present: Kimberly A. McMullen, Michael J. Smith, J. Kevin Fitzpatrick, Eric S. Berger, and Brenten S. Dum. Also present: Secretary Danielle Shope, Mayor Arlis Krammes and Solicitor Randy Zimmerman.

The reorganization meeting was called to order by Mayor Arlis Krammes at 6:30 p.m.

Mayor Arlis Krammes administered the Oaths of Office to the following Council members: Eric S. Berger, Brenten S. Dum, J. Kevin Fitzpatrick, Kimberly A. McMullen, and Michael J. Smith.

Nominations for Vice President (Mayor): Council President J. Kevin Fitzpatrick made the motion to nominate Eric S. Berger for Borough Council Vice President, seconded by Councilman Brenten S. Dum. Motion carried by show of all hands.

Mayor Arlis Krammes turned the gavel over the President J. Kevin Fitzpatrick.

Nominations for President Pro Tem - Councilman Michael J. Smith was nominated for President Pro Tem, seconded by Council Vice President Eric Berger. Motion carried by show of all hands.

Appointments/Reappointments to Boards and Committees –

***Reappointments (5 year term)**

Margaret G. Kingsborough was nominated by Councilman Smith to a five year term (1/1/2020-12/31/2024) on the Bloomfield Municipal Authority, seconded by Vice President Berger. Motion carried.

C. Larry Weller was nominated by Councilman Smith to a five year term (1/1/2020-12/31/2024) on the Bloomfield Borough Water Authority, seconded by Vice President Berger. Motion carried.

Nathan Mohler was nominated by Vice President Berger to a five year term (1/1/2020-12/31/2024) on the Bloomfield Borough Planning Commission, seconded by Councilwoman McMullen. Motion carried.

Council President J. Kevin Fitzpatrick declined his reappointment to the Bloomfield Borough Planning Commission due to conflict of interest since he is now the Bloomfield Borough Council President. Someone else will need to be asked to fill this position.

***Reappointments (3 year term)**
