## Part 1

### General Regulations

#### **§1. Definitions and Interpretation.<sup>1</sup>**

- (a) Words and phrases, when used in this ordinance,<sup>2</sup> shall have the meanings ascribed to them in The Vehicle Code of Pennsylvania, as now in force, or as hereafter amended, enacted or reenacted, except where the context clearly indicates a different meaning.
- (b) The term "legal holidays" as used in this ordinance shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas.
- (c) In this ordinance, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.<sup>3</sup>

#### **§2. Manner of Adopting Permanent Traffic and Parking Regulations.**

All traffic, and parking regulations of a permanent nature shall be enacted as ordinances or as parts of ordinances or as amendments to ordinances of the Borough of Bloomfield, (Ord. 123, 7/8/1975, Art. I, §2)

#### **§3. Temporary and Emergency Regulations.**

The Mayor shall have the following powers to regulate traffic and parking temporarily and in time of emergency:

- (a) In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations;
- (b) In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.

Such temporary and emergency regulations shall be enforced by the Mayor and the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or tractor in violation of any such regulations, or who shall move, remove, destroy, injure or deface any sign or marking erected, posted or made to give notice of any such regulation, shall, upon conviction thereof, be liable to the penalty set forth in the law or elsewhere in this ordinance<sup>4</sup> for a violation of such nature, and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this ordinance, to a fine of not more than \$10 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than five days. ### **§4. Experimental Regulations.**

The Borough Council may, from time to time, designate places upon and along the highways in the Borough where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective just as if they had been specified in this ordinance.<sup>5</sup> No person shall operate or park a vehicle or tractor in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who shall violate any provision of this section shall, upon conviction thereof, be liable to the penalty set forth in the law or elsewhere in this ordinance for a violation of such nature, and in case of a violation for which no specific penalty is set forth in the law or elsewhere in this ordinance, to a fine of not more than \$10 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than five days. Provided: the purpose of this section is to allow for test and experimental determination of the feasibility and desirability of permanent changes in the ordinance of the Borough relative to traffic and parking. ### **§5. Authority of Peace Officers.**

The peace officers of the Borough are hereby given authority to direct traffic on the highways, of the Borough, and at intersections thereof. <sup>6</sup> (Ord. 123, 7/8/1975, Art. I, §5)

**Part 2**

**Traffic Regulations**

**§21. Motor Vehicles not to be Driven on Sidewalks.**

No person shall operate a motor vehicle or tractor upon any sidewalk in the Borough, nor shall any person operate a motor vehicle upon or across any sidewalk except in order to gain access to or egress from a driveway or alley at such locations where the curb, if such sidewalk is curbed, shall have been properly cut down for the purpose. Any person who shall violate any provision of this section shall, upon conviction thereof, be sentenced to pay a fine of not more than \$50 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than 10 days. **§22. Speed Limits Established.**

1. The speed limit for all Borough streets within the boundaries of the Borough of Bloomfield is hereby established at 25 miles per hour. The speed limit on all alleys shall be 15 miles per hour.
2. Any person who shall operate a vehicle or tractor in excess of the speed limit established above, shall, upon conviction thereof, be sentenced to pay a fine and costs as set forth in Title 75 of the Vehicle Code, 1976, June 17, P.L.162. No. 81, 75 Pa C.S.A §101 et seq.

**§23. Traffic to Keep to Right of Certain Center Structures and Barriers.**

All vehicular traffic shall keep to the right of the following structures or barriers located in the center of the specified intersections:

- (a) Carlisle Street and Main Street - Soldiers and Sailors Monument

Any person who shall operate a vehicle or tractor in violation of any provision of this section shall, upon conviction thereof, be sentenced to pay a fine of not more than \$10 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than five days.

**§25. Stop Intersections Established.**

The following intersections (in addition to highways intersecting with the through highways established by Section 4 of this article) <sup>7</sup> are hereby established as stop intersections, and official stop signs shall be erected (or are hereby confirmed if heretofore erected) in such a position as to face traffic approaching the second-named highway upon the first-named highway, in the direction or directions hereby indicated. All vehicles and tractors approaching any such intersection upon the first-named highway, in the direction or directions hereby indicated in each case, shall come to a full stop, within a reasonable distance, before entering any such intersection:

Any operator of a vehicle who shall fail to come to a full stop, within a reasonable distance before entering any stop intersection, as hereinabove required, shall, upon conviction thereof, be sentenced to pay a fine of \$25 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than 12 days.

### **§26. Vehicle Weight Limits Established.**

It shall be unlawful for any person to operate any motor vehicle or other tractor, trailer or tractor-trailer combination, having a gross weight in excess of that herein respectively prescribed, upon any of the following highways or portions thereof:

1. Cherry Street	McClure Street and Barnett Street	6,000 pounds
2. Barnett Woods Road	McClure Street and the southern terminus of the Borough	16,000 pounds

Any person who shall violate any provision of this section shall, upon conviction thereof, be sentenced to pay a fine of \$50 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than 10 days. ### **§27. Certain Classes of Vehicles Prohibited on Certain Highways.**

It shall be unlawful for any person to operate any vehicle or tractor, except a passenger vehicle, but not including a passenger vehicle towing any trailer or towing any other vehicle upon any of the following portions of the highways in the Borough:

<b>Highway</b>	<b>Between</b>
1. Barnett Woods Road	McClure Street and the southern terminus of the Borough

Any person who shall violate any provision of this section upon conviction thereof shall be sentenced to pay a fine of \$50 and costs of prosecution and in default of payment of such fine and costs to imprisonment for not more than 10 days.

Provided: nothing herein shall prohibit the operation of any commercial vehicle, tractor or tractor towing any machinery or other vehicle upon any highway or portion thereof listed hereinabove where

such operation thereon shall be necessary in order to pick up or deliver any goods, wares, merchandise or material from or to any premises located upon any such highway or portion thereof or necessary in any farming operation at any premises located upon any such highway or portion thereof. **§28. Unlawful to Operate Motor Vehicles or Tractors on Highways Closed for Construction or Repair.**

It shall be unlawful for any person to operate any vehicle or tractor upon any highway in the Borough that is under construction, resurfacing or repair, in disregard of any official sign, barricade or notice that the same is closed to vehicular traffic. Any person who shall violate any provision of this section shall, upon conviction thereof, be sentenced to pay a fine of not more than \$25 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than 10 days. **§29. Play Highways Authorized.**

The Mayor is hereby authorized to designate as play highways, whenever he shall deem such action advisable, and for whatever period of time directed by him, any portion of any highway in the Borough whereon sledding and coasting shall be permitted. Such highway shall be set apart for the purpose under the direction of the Mayor.

No person shall operate any motor vehicle or tractor upon any play highway at any time when such highway shall be so designated, except in case of emergency, with special permission of the Mayor or of the police officer in charge, who shall first clear such play highway of all persons using such highway for the purpose for which it was set aside. Any person who shall violate any provision of this section shall, upon conviction thereof, be sentenced to pay a fine of not more than \$10 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than five days.

**§30. Use of Engine Retarders or Compression Brakes, Except in Emergencies.**

1. The use of compression brakes, also known as engine retarders or exhaust brakes or hydraulic retarders on commercial vehicles so equipped, operated on any of the highways, streets and/or alleys within the Borough of Bloomfield shall be prohibited, except in the event, of clear and present emergencies.
2. Any person who shall violate this Section shall, upon conviction thereof, be sentenced to pay a fine of not more than \$100 and the costs of prosecution.

**Part 3**

**Parking Regulations**

**§51. Parking Without Lights Authorized.**

The boundary limits of the Borough of Bloomfield are hereby established as a zone in which motor vehicles may remain standing without lights, and all highways within such boundary limits are hereby designated as highways where motor vehicles may remain standing without lights. (Ord. 123, 7/8/1975, Art. III, §1)

**§52. Vehicles to be Parked Within Marked Spaces.**

Whenever a space shall be marked off on any highway for the parking of an individual vehicle, every vehicle there parked shall be parked within the lines bounding such space. (Ord. 123, 7/8/1975, Art. III, §2)

**§53. Angle Parking Required on Portions of Certain Highways.**

Only angle parking shall be permitted on the following portions of the highways:

<b>Highway</b>	<b>Side</b>	<b>Location</b>
1. Main Street	Both	Area west of Soldiers and Sailors Monument

On all highways or portions thereof where angle parking is now or shall hereafter be authorized, all vehicles parked thereon shall be parked with the front thereof nearest the curb. Truck and van parking shall be prohibited in the first two angle parking spaces on the south side of Main Street in the area west of the Soldiers and Sailors Monument. (Ord. 123, 7/8/1975, Art. **§54. Parking Prohibited at All Times in Certain Locations.**

Parking shall be prohibited at all times in the following locations:

Barnett Woods Road	North and South	Entire Length
Carlisle Street	West and North	Approximately 200 feet south of the entrance to CLMI north to the borough line.

### **§55. Parking Prohibited on All Bridges.**

Parking is hereby prohibited on all bridges located in the Borough at any and all times. (Ord. 123, 7/8/1975, Art. III, §5)

### **§56. Parking Prohibited in Specific Locations Certain Days and Hours.**

Parking shall be prohibited in the following locations at all times on the days and between the hours hereby indicated:

High Street	North	Chestnut Alley west to Apple Street	Sunday	8:00 AM to 1:00 PM

### **§57. Parking Time Limited in Specific Locations Certain Days and Hours.**

No person shall park a vehicle, or allow the same to remain parked for longer than the time herein indicated, in any of the following locations, at any time on the days and between the hours herein indicated;

#### §58. Parking Time Limit

- A. **Tractor or Combination Tractor-Trailer** – No person shall park or locate any tow behind licensed vehicle or trailer, or allow it to stand, upon any street, alley, or other public place within the Borough of Bloomfield except as provided in this ordinance. (Ord. 123, 7/8/1975, Art III, §8; as amended by Ord. 303, 1/2/2012, §2A)
- B. **Licensed Tow Behind Vehicles, Trailers and Campers** – No person shall park or let standing any tow behind licensed vehicle or trailer upon any street, alley, or public place within the Borough of Bloomfield without being attached to an operable vehicle for a period in excess of five (5) days without the specific approval of the Borough Council.
- Absent express Borough Council approval, no person shall park any licensed tow behind vehicle, trailer or camper, on any public place in the Borough for a period of time that is otherwise permitted for parking of such vehicles on said streets, alleys, or public places. Any person violating the provisions of this section shall be subject to the penalties provided hereinafter. (Ord. 123, 7/8/1975, Art III, §8; as amended by Ord. 303, 10/2/2012, §2B)
- C. **Licensed Trailers, Campers and Dependiant Vehicles** – No such person may occupy a dependent vehicle, tow behind vehicle, trailer or camper for purposes of residency for a period to exceed fifteen (15) days without express permission of Borough Council. (Ord. 123, 7/8/1975, Art III, §8; as amended by Ord. 303, 10/2/2012, §2C)
- D. All other provisions of Chapter 14 shall remain in full force and effect. (Ord. 123, 7/8/1975, Art III, §8; as amended by Ord. 303, 10/2/2012, §3)

**§59. Ticketing of Vehicles Parked Unlawfully; Effect of Payment Within 72 Hours**

1. It shall be the duty of the police officer and/or parking enforcement personnel to report to the Mayor all violations of this Part indicating, in each case:
  - A. The Section thereof violated.
  - B. The license number of the vehicle involved in such violation.
  - C. The location where such violation took place.
  - D. The time of such violation.
  - E. Any other facts that might be necessary in order to secure a clear understanding of the circumstances attending such violation.
2. The police officer or parking enforcement personnel making the report shall also place on or attach to the vehicle a notice to the owner or driver of the vehicle that the vehicle was parked in violation of this Part, and instructing the owner or driver that if he will pay the sum of \$20 by mail to the Borough at P.O. Box 144, New Bloomfield, PA 17068, for the use of the Borough, postmarked within 72 hours after the time of the notice, that act will save the violator from prosecution and from payment of the fine prescribed in Section 60 of this Part.

**§60. Penalty for Violation.**

Any person who violates any provision of this Part, and who fails to pay the fine set forth in Section 59 within the time frame set forth therein, shall be cited within 30 days after the commission of the offense or 30 days after discovery of the commission of the offense or the identity of the offender, whichever is later, and upon conviction thereof in a summary proceeding, be sentenced to pay a fine of \$50 and the costs of prosecution. **§61. Parking Against Traffic Permitted at Specific Locations.**

Parking shall be permitted against traffic on the following streets:

Street	Side	Between
East High Street	Both	North Carlisle Street and the terminus of East High Street at Hickory Alley

## Part 4

### Interpretation

#### **§101. Severability.**

The provisions of this ordinance<sup>8</sup> shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, such decision shall not affect the validity of any of the remaining provisions of this ordinance. It is hereby declared as a legislative intent that this ordinance would have been adopted had such unconstitutional, illegal or otherwise invalid provision not been included herein. (Ord. 123, 7/8/1975, Art IV, §1)

#### **§102. Provisions to be a Continuation of Existing Regulations.**

The provisions of this ordinance,<sup>9</sup> so far as they are the same as those of ordinances and regulations in force immediately prior to the enactment of this ordinance, are intended as a continuation of such ordinances and regulations and not as new enactments. The provisions of this ordinance shall not affect any act done or liability incurred, nor shall they affect any suit of prosecution pending or to be instituted to enforce any of these repealed ordinances or regulations.<sup>10</sup> (Ord. 123, 7/8/1975, Art IV, §2)
